New well pump with variable frequency drive; 1,900 feet of water transmission line; well pump power, controls and portable generator; and pump house improvements including building addition, new booster pump, piping and appurtenances, hydropneumatic tanks, controls, electrical, heaters, and doors.

American Iron and Steel
